AKTA KESELAMATAN SOSIAL PEKERJA 1969

PERATURAN-PERATURAN KESELAMATAN SOSIAL PEKERJA
(AMAUN FAEDAH PENGURUSAN MAYAT) (PINDAAN) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 105 Akta Keselamatan Sosial Pekerja 1969 [*Akta 4*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerja (Amaun Faedah Pengurusan Mayat) (Pindaan) 2024**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Jun 2024.

Pindaan peraturan 3

2. Peraturan-Peraturan Keselamatan Sosial Pekerja (Amaun Faedah Pengurusan Mayat) 2017 [*P.U. (A) 141/2017*] dipinda dalam peraturan 3—

(a) dalam subperaturan (1), dengan menggantikan perkataan “dua ribu ringgit” dengan perkataan “tiga ribu ringgit”; dan

(b) dalam subperaturan (2)—

(i) dalam perenggan (a), dengan menggantikan perkataan “dua ribu ringgit” dengan perkataan “tiga ribu ringgit”; dan

(ii) dalam perenggan (b), dengan menggantikan perkataan “dua ribu ringgit” dengan perkataan “tiga ribu ringgit”; dan

(iii) dalam perenggan (c), dengan menggantikan perkataan “enam ribu lima ratus ringgit” dengan perkataan “tujuh ribu lima ratus ringgit”.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (AMOUNT OF FUNERAL BENEFIT)
(AMENDMENT) REGULATIONS 2024

IN exercise of the powers conferred by section 105 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Employees' Social Security (Amount of Funeral Benefit) (Amendment) Regulations 2024**.

(2) These Regulations come into operation on 1 June 2024.

Amendment of regulation 3

2. The Employees' Social Security (Amount of Funeral Benefit) Regulations 2017 [P.U. (A) 141/2017] are amended in regulation 3—

(a) in subregulation (1), by substituting for the words “two thousand ringgit” the words “three thousand ringgit”; and

(b) in subregulation (2)—

(i) in paragraph (a), by substituting for the words “two thousand ringgit” the words “three thousand ringgit”;

(ii) in paragraph (b), by substituting for the words “two thousand ringgit” the words “three thousand ringgit”; and

(iii) in paragraph (c), by substituting for the words “six thousand five hundred ringgit” the words “seven thousand five hundred ringgit”.
