AKTA KESELAMATAN SOSIAL PEKERJA 1969
PERATURAN-PERATURAN KESELAMATAN SOSIAL PEKERJA
(AMAUN FAEDAH PENGURUSAN MAYAT) 2017

PADA menjalankan kuasa yang diberikan oleh seksyen 105 Akta Keselamatan Sosial Pekerja 1969 [*Akta 4*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerja (Amaun Faedah Pengurusan Mayat) 2017**.

(2) Peraturan-Peraturan ini disifatkan telah mula berkuat kuasa pada 1 Julai 2016.

Pemakaian

2. Peraturan-Peraturan ini hendaklah terpakai bagi semua kes kematian di bawah seksyen 29 Akta jika kematian itu berlaku pada atau selepas 1 Julai 2016.

Faedah pengurusan mayat

3. Amaun faedah pengurusan mayat yang kena dibayar di bawah seksyen 29 Akta ialah dua ribu ringgit.

Pembatalan

4. Peraturan-Peraturan Keselamatan Sosial Pekerja (Amaun Faedah Pengurusan Mayat) 1998 [*P.U. (A) 86/1998*] dibatalkan.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (AMOUNT OF FUNERAL BENEFIT)
REGULATIONS 2017

IN exercise of the powers conferred by section 105 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Employees' Social Security (Amount of Funeral Benefit) Regulations 2017**.

(2) These Regulations are deemed to have come into operation on 1 July 2016.

Application

2. These Regulations shall apply to all cases of death under section 29 of the Act where the death occurs on or after 1 July 2016.

Funeral benefit

3. The amount of the funeral benefit payable under section 29 of the Act shall be two thousand ringgit.

Revocation

4. The Employees' Social Security (Amount of Funeral Benefit) Regulations 1998 [P.U. (A) 86/1998] are revoked.
