**AKTA KESELAMATAN SOSIAL PEKERJA 1969**

**PERATURAN-PERATURAN KESELAMATAN SOSIAL PEKERJA (KADAR BULANAN ELAUN LAYANAN SENTIASA) 2013**

PADA menjalankan kuasa yang diberikan oleh seksyen 30 dan 105 Akta Keselamatan Sosial Pekerja 1969 [*Akta 4*], Menteri membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerja (Kadar Bulanan Elaun Layanan Sentiasa) 2013.**

(2) Peraturan-Peraturan ini hendaklah disifatkan telah mula berkuat kuasa pada 1 Januari 2013.

**Kadar bulanan elaun layanan sentiasa**

2. Kadar bulanan elaun layanan sentiasa bagi orang berinsurans yang berhak mendapat pencegah ilat atau faedah hilang upaya langsung yang kekal yang disebut dalam seksyen 30 Akta ialah lima ratus ringgit.

**Kadar bulanan elaun layanan sentiasa sebelum 1 Januari 2013**

3. Walau apa pun peraturan 2, kadar bulanan elaun layanan sentiasa bagi mana-mana orang berinsurans yang telah berhak mendapat elaun layanan sentiasa sebelum 1 Januari 2013 adalah tertakluk kepada subseksyen 7(2) Akta Keselamatan Sosial Pekerja (Pindaan) 2012 [*Akta A1445*].

**Pembatalan**

4. Peraturan-Peraturan Keselamatan Sosial Pekerja (Amaun Bulanan Maksimum Elaun Layanan-Sentiasa) 1992 [P.U. (A) 285/1992] dibatalkan.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (MONTHLY RATE OF CONSTANT-ATTENDANCE ALLOWANCE) REGULATIONS 2013

IN exercise of the powers conferred by sections 30 and 105 of the Employees' Social Security Act 1969 [*Act 4*], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Employees' Social Security (Monthly Rate of Constant-Attendance Allowance) Regulations 2013**.

(2) These Regulations shall be deemed to have come into operation on 1 January 2013.

**Monthly rate of constant-attendance allowance**

2. The monthly rate of constant-attendance allowance for an insured person who is entitled to invalidity pension or permanent total disablement benefit referred to in section 30 of the Act is five hundred ringgit.

**Monthly rate of constant-attendance allowance before 1 January 2013**

3. Notwithstanding regulation 2, the monthly rate of constant-attendance allowance for any insured person who has been entitled to the constant-attendance allowance before 1 January 2013 is subject to subsection 7(2) of the Employees' Social Security (Amendment) Act 2012 [*Act A1445*].

**Revocation**

4. The Employees' Social Security (Maximum Monthly Amount of Constant-Attendance Allowance) Regulations 1992 [P.U. (A) 285/1992] are revoked.
