PERINTAH KESELAMATAN SOSIAL PEKERJAAN SENDIRI  
(PINDAAN JADUAL PERTAMA) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 84 Akta Keselamatan Sosial Pekerjaan Sendiri 2017 [*Akta 789*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Keselamatan Sosial Pekerjaan Sendiri (Pindaan Jadual Pertama) 2020.**

(2) Perintah ini mula berkuat kuasa pada 7 Oktober 2020.

**Pindaan Jadual Pertama**

2. Jadual Pertama kepada Akta Keselamatan Sosial Pekerjaan Sendiri 2017 dipinda dalam subperenggan 1(c) dengan menggantikan takrif "kenderaan perkhidmatan awam" dengan takrif yang berikut:

' "kenderaan perkhidmatan awam"—

- (a) berhubung dengan Semenanjung Malaysia, mempunyai erti yang diberikan kepadanya dalam Akta Pengangkutan Awam Darat 2010 [*Akta 715*]; dan
- (b) berhubung dengan Sabah, Sarawak dan Wilayah Persekutuan Labuan, mempunyai erti yang diberikan kepadanya dalam Akta Lembaga Pelesenan Kenderaan Perdagangan 1987 [*Akta 334*].'

SELF-EMPLOYMENT SOCIAL SECURITY ACT 2017

SELF-EMPLOYMENT SOCIAL SECURITY  
(AMENDMENT OF FIRST SCHEDULE) ORDER 2020

IN exercise of the powers conferred by section 84 of the Self-Employment Social Security Act 2017 [Act 789], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Self-Employment Social Security (Amendment of First Schedule) Order 2020**.

(2) This Order comes into operation on 7 October 2020.

**Amendment of First Schedule**

2. The First Schedule to the Self-Employment Social Security Act 2017 is amended in subparagraph 1(c) by substituting for the definition of “public service vehicle” the following definition:

‘“public service vehicle”—

(a) in relation to Peninsular Malaysia, has the meaning assigned to it in the Land Public Transport Act 2010 [Act 715]; and

(b) in relation to Sabah, Sarawak and the Federal Territory of Labuan, has the meaning assigned to it in the Commercial Vehicles Licensing Board Act 1987 [Act 334].’.
