(PINDAAN) (NO. 2) 2021

PADA menjalankan kuasa yang diberikan oleh perenggan 83(2)(h) Akta Keselamatan Sosial Pekerjaan Sendiri 2017 [*Akta 789*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerjaan Sendiri (Pindaan) (No. 2) 2021**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Oktober 2021.

SELF-EMPLOYMENT SOCIAL SECURITY ACT 2017

SELF-EMPLOYMENT SOCIAL SECURITY (AMENDMENT) (NO. 2) REGULATIONS 2021

IN exercise of the powers conferred by paragraph 83(2)(h) of the Self-Employment Social Security Act 2017 [Act 789], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Self-Employment Social Security (Amendment) (No. 2) Regulations 2021**.

(2) These Regulations come into operation on 1 October 2021.

Amendment of First Schedule

2. The Self-Employment Social Security Regulations 2018 [P.U. (A) 326/2018] are amended in the First Schedule by inserting after paragraph 3 the following paragraph:

“4. Self-Employment Social Security (Rates of Contribution for Person Carrying Out Service of Carriage and Delivery of Goods or Food) Regulations 2021 [P.U. (A) 372/2021]”.
