Adakah Anda Hilang Pekerjaan?

Kerajaan telah memperuntukkan bayaran interim sebanyak RM122 juta kepada pekerja yang hilang pekerjaan dalam tempoh **1 Januari 2018 hingga 31 Disember 2018**.

Ini merupakan inisiatif di bawah Sistem Insurans Pekerjaan (SIP) bagi meringankan beban pekerja yang kehilangan pekerjaan.



Pekerja yang layak akan menerima eluan tunai sebanyak RM 600 sebulan bagi tempoh maksima 3 bulan.

Payment will be credited directly to the applicant's bank account

## QUALIFYING CONDITIONS

- Loss of employment occurs in 2018
- Lost of jobs or being retrenched
- Forced resignation
- Firms / factory closed operations/ redundancy
- VSS / MSS is also eligible for interim
- Resignation due to employer's breached the terms of the contract. Examples fail to pay the salary within the prescribed period
- Resignation due to sexual harassment at work place
- Claim must be made within 60 days from the date of loss of employment

**Have You Lost Your Job?**

The Government has provided an interim assistance of RM122 million to employees who lost their jobs within 1 January 2018 to 31 December 2018.

This is an initiative under the Employment Insurance System (EIS) to ease the burden of workers who are losing their jobs.



Eligible workers are entitled for interim payment of RM 600 per month for a maximum of 3 months.
