Social Security Protection For Domestic Workers

- Effective 1st June 2021, it is mandatory for employers to register local and foreign domestic workers with PERKESO to ensure that they are protected in the event of any accidents or occupational diseases arising out of and in the course of their employment.
- Failure to register the domestic workers with PERKESO is an offence under Employees' Social Security Act 1969 (Act 4) and if found guilty, can be fined not more than RM10,000.00 or 2 years imprisonment or both.

Eligibility Requirement

Local Domestic Worker

- Malaysian citizen / Permanent Resident / **Temporary Resident Worker**
- Employed by a Malaysian citizen / Permanent Resident / Temporary Resident or foreign employer

Foreign Domestic Worker

- Soreign domestic worker who possess passport and work pass issued by the Immigration Department of Malaysia
- Employed by Malaysian employer / Permanent Residents / Temporary Residents

Upon having access to ASSIST's portal, employers must register together with their employees by providing supporting documents as followed:

Registration under Act 4

- i) Form 1 (Employer's Registration Form)
- ii) Domestic Worker's Registration Form
- iii) Copy of Employer's latest Identification Card / Passport
- iv) Copy of Domestic Worker's latest Identification Card / Passport
- v) Copy of Work Pass (foreign domestic workers only)

Registration under Act 800 (if related)

- i) Form SIP 1 Employer's Registration Form
- ii) Form SIP 2- Employee's Registration Form
- Other than the online registration method, registration for employers and domestic workers can also be done at the PERKESO Office.
