AKTA KESELAMATAN SOSIAL PEKERJA 1969

PEMBERITAHUAN KESELAMATAN SOSIAL PEKERJA (PENGEQUALIAN) (NO. 2) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 98 Akta Keselamatan Sosial Pekerja 1969 [*Akta 4*], Menteri membuat pemberitahuan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Pemberitahuan ini bolehlah dinamakan **Pemberitahuan Keselamatan Sosial Pekerja (Pengecualian) (No. 2) 2018**.

(2) Pemberitahuan ini mula berkuat kuasa pada 1 Januari 2019.

**Pengecualian**

2. (1) Menteri mengecualikan daripada kuat kuasa Akta mana-mana pekerja yang diinsuranskan oleh majikannya di bawah suatu polisi insurans bagi maksud Skim Pampasan Pekerja Asing di bawah Perintah Pampasan Pekerja (Skim Pampasan Pekerja Asing) (Insurans) 2005 [*P.U. (A) 45/2005*] yang terus terpakai bagi pekerja itu pada atau selepas pembatalan Perintah itu sebagaimana yang diperuntukkan di bawah perenggan 3 Perintah Pampasan Pekerja (Skim Pampasan Pekerja Asing) (Insurans) (Pembatalan) 2018 [*P.U. (A) 350/2018*].

(2) Pengecualian di bawah subperenggan (1) hendaklah terpakai bagi pekerja itu sehingga habis tempoh polisi insurans itu.

(3) Walau apa pun subperenggan (2), jika polisi insurans yang disebut dalam subperenggan (1) habis tempoh selepas 31 Disember 2019, pengecualian di bawah subperenggan (1) hendaklah terpakai bagi pekerja itu sehingga 31 Disember 2019.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (EXEMPTION) (NO. 2) NOTIFICATION 2018

IN exercise of the powers conferred by section 98 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following notification:

**Citation and commencement**

1. (1) This notification may be cited as the **Employees' Social Security (Exemption) (No. 2) Notification 2018**.

(2) This Notification comes into operation on 1 January 2019.

**Exemption**

2. (1) The Minister exempts from the operation of the Act any workman who is insured by his employer under an insurance policy for the purpose of the Foreign Workers' Compensation Scheme under the Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) Order 2005 [P.U. (A) 45/2005] which continues to apply to such workman on or after the revocation of such Order as provided under paragraph 3 of the Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) (Revocation) Order 2018 [P.U. (A) 350/2018].

(2) The exemption under subparagraph (1) shall apply to such workman until the expiry of such insurance policy.

(3) Notwithstanding subparagraph (2), where the insurance policy referred to in subparagraph (1) expires after 31 December 2019, the exemption under subparagraph (1) shall apply to such workman until 31 December 2019.
