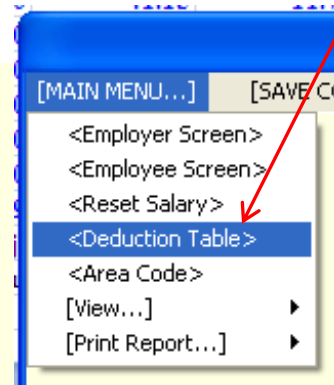
3 Follow the steps below;

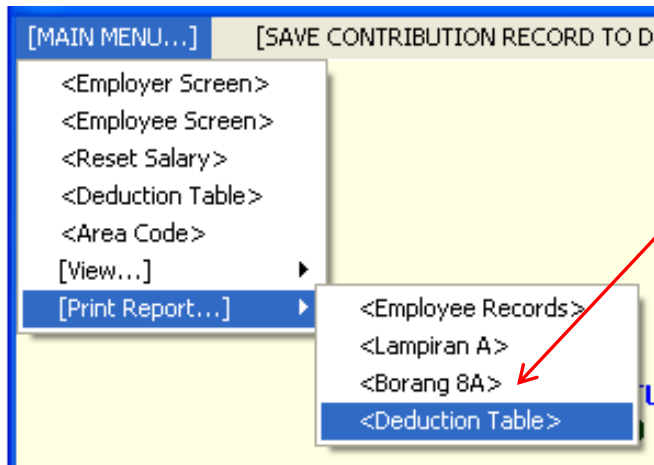
